### Cancellation Policy

In the event of a cancellation before 15 April 2026, 50% of the registration fee will be refunded. If the cancellation occurs after 15 April 2026, the registration fee will not be refunded.

The IMZ reserves the right to cancel the workshop until 03 April. In the event of a cancellation, all participants will receive a full refund of the registration fee. Any travel and accommodation booked individually will not be reimbursed by the IMZ.
